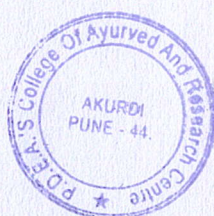
A Website Committee is formed for the administration of the institute website.

Telemedicine is a healthcare service that leverages technology to provide remote medical consultations and support. This facility is available if required and runned successfully in Covid pandemic period.

12. Library

The Institute continues to maintain its academic excellence through maintaining a well-stocked library. It is equipped with partial automated software system to manage. Complete automation of the library system in process and is expected to be completed soon. The Library has installed automated ILMS software (**Auto-Lib NG and PDEA ERP system**) in which enrolment of all textbooks, reference books, Journals, e-journals etc. is done.

Apart from the ILMS, the library also uses PDEA- ERP system for accessing the data of the readers and maintain their record. Through this, students are enabled to access OPAC- Online Public Access Catalogue and search the books.

The library also has a well-established Digital Library for students with access to sources like DELNET, e- PG Pathashala, National Digital Library of India, MUHS Knimbus Library.

13. Administration –

The college administration is made easy due to PDEA's ERP software (cloud base). In this software batch wise enrolment of students is done. Due to this software it made easy to provide demand letters of fee, Bonafide certificate to students, college leaving certificate etc.

Biometric/ face Based Attendance Management Software is used by Administrative Staff, students and Teaching Faculty to record and track attendance.

PDEA's EMS system is established for profile update of teaching and non-teaching staff. With this system leave application is generated and leave is approved by branch authority. Administrative Office is using Excel and File Management System Tools to maintain effective database.

For administration of ARSMH hospital, we have Ayursoft software. Daily entry of OPD and IPD patients is done along with lab, panchakarma etc. services. Due to this, all data required for NCISM and other purpose can be retrieve easily.

ICT TOOLS

1. Hardware Infrastructure

- The College has adequate number of desktops for students and staff.
- Computers and printers are made available in the administrative block and all departments.
- Projectors and other multimedia devices are provided in the auditorium, classrooms, seminar rooms and laboratories.

- Office automation packages for desktops like Open Office, MS Office and Antivirus are purchased and updated regularly.

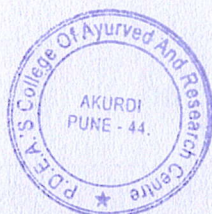
College campus is under CCTV surveillance.

H.O.D. and submits the requirement on E-tendering Portal. The registered Dealers are informed about the requirements and then dealers submit the quotations on E-tendering Portal. The parent institute finalizes the purchase order.

15. Student Admission and Support -

UG and PG admissions of students is made under Government of Maharashtra through state Common Entrance Test Cell, Maharashtra State by online mode. College receives list of students through software by CET cell. All required documents are also provided through software.

The Institute brings out its Brochure which is displayed on the website that has admission notification & guidelines for the admission process. Number of students applying to each course, withdrawals, fee submission, all information to be displayed through this website only.

Fellowship and PhD admissions are made through MUHS, Nashik by online mode.

16. Examination -

With the change from offline to online examinations, the usage of e-communication platforms and technologies has become mandatory in exam process.

Internal examinations are conducted on a year-wise and subject-wise basis by the respective departments for all Undergraduate and Postgraduate programs, following the guidelines set by the Examination Department of MUHS. For this, the institute displays Time table and Results of Internal Examination on Notice board and share the same on What's App to all the students.

Monthly Question and assignments are regularly posted on Google Classrooms for each and every year students.

The Institutional Examinations are being conducted under the guidance of MUHS Nashik. The entire Annual exams are taken as per university guidelines. Applications for the University Examinations are filled online. University displays Time table and Results on the University Website (www.muhs.ac.in).

Institute is serving as a centre for M.U.H.S examination. As per guideline by MUHS, institute has developed peripheral scanning centre for digital evaluation of papers which will help to avoid the physical handling of the answer sheet, to reduce any type of malpractice and declaration of results in stipulated time. For this purpose, University in collaboration with one IT company has design a special software. After every day theory papers, all pages of the answer sheet are scanned and after quality check it will be uploaded in the software on the same day for further evaluation. Scanning centre is under CCTV surveillance and it has access to university.
