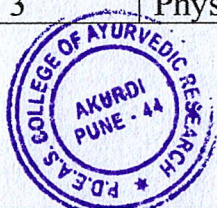

Scheme for indigent and weaker Patients

PDEA's Ayurved Rugnalaya and Sterling Multispecialty Hospital, attached to College of Ayurved and Research Centre, Akurdi, Pune is governed by the Pune District Education Association in Pune. The institution is registered under the Maharashtra Public Trust Act of 1950. Therefore, it is mandatory for the institute to implement the Scheme for the indigent and Weaker Patients under Sections 41 A A of the Maharashtra Public Trust Act, 1950.

As per the direction of Hon'ble Joint Charity Commissioner Pune and guidance of the concerned office this scheme 41A A under Maharashtra Public Trust Act 1950 was started in Ayurved Rugnalaya and Sterling Multispecialty Hospital from January 19, 2015.

As per provision of this scheme

- (1) **Indigent patients:** Those patient whose annual income is less than 1,80,000/- or those who fall below poverty line are liable to free medical facilities which are available in this institute.
- (2) **Weaker Patients:** The patient whose annual income is less than 3,60,000/- is required to be treated at 50% subsidized rate as per facilities which are available in this institute.
- (3) 10% of the number of beds registered in the hospital is used for indigent and Weaker Patients respectively. According to this 220 beds are registered, out of them 22 beds are reserved for the poor and 22 beds are reserved for the weaker.
- (4) Separate bank account (IPF) is maintained in the name of the institute for expenditure incurred during treatment under the scheme. Every month, 2% of the total bill amount of patient's treatment is deposited in this account. The monthly report containing number of indigent and weaker patients, their expenditure and amount deposited for them is submitted to Hon. Joint Charity Commissioner, Pune and Hon. District collector office.
- (5) The meeting of all the charity hospital is held every three months under the chairmanship of the Hon'ble District Collector.
- (6) The office of the Hon. Joint Charity Commissioner conducts regular inspections regarding this scheme and gave guidelines accordingly
- (7) The institute has appointed a coordinating officer for smooth working of scheme.
